During this period, only members and privilege members shall be allowed to patronize the Club.

Non members, guests and reciprocal members shall not be allowed to enter the Club's premises until further notice.

GOLF

Golf Competitions (including corporate) shall remain suspended until further notice.

BUGGY

1. One golfer per buggy.

CHANGING ROOM

1. The Men and Ladies Changing Room shall remain open.
2. Only twenty (20) members are allowed, at a time at the Men's Changing Room.
3. Only ten (10) members are allowed, at a time at the Ladies Changing Room

F&B

1. F&B outlets shall operate from 6.30 am until 10.00 pm.
2. Only two person(s) shall be allowed to be seated at each table.
3. Members are required to register using My Sejahtera or SeLangkah at each F&B outlet.
4. Seminars/Trainings/Banquets/Workshops shall not be permitted until further notice.

OTHERS

1. Members are required to perform the mandatory temperature screening, register using the QR Code and sanitize their hands (hand sanitizer shall be provided) at Parking 1 of the Club.
2. Members are required to wear their face masks at the Club's premises at all times.
3. Members are required to practice good personal hygiene by washing their hands or by applying hand sanitizers provided at all F&B outlets and F&B counters.
4. Physical distancing must be observed by members at all times.
5. Members are encouraged to minimize their time spent at the Club after their activities.
6. Members are discouraged from shaking hands with other members.
7. Members are encouraged to sanitize their golf equipment(s) before entering the Club.
